Subject: Notice regarding Physical Standard Test (PST) and Physical Efficiency Test (PET) for the post of Forester, Wildlife Forester advertised vide Advertisement Notice No. 03 of 2022 dated 30-11-2022 and Wildlife Guards/Antipoaching Guards, Forest Guard advertised vide Advertisement Notice No. 02 of 2022 dated 2022.

The candidates qualifying the stage of Document Verification (DV) for the post of Forester, Wildlife Forester and Wildlife Guards/Antipoaching Guards, Forest Guard as listed in Annexure-I and II respectively, are provisionally shortlisted for the Physical Standard Test (PST) & Physical Efficiency Test (PET).

- Depending on the number of vacancies of the posts and score/merit of candidates in the OMR Based Examination, the DV qualified candidates are called for PST/PET in the ratio of 1:5.
- The PST and PET will be conducted on **07-10-2023 (Saturday)**.
- Physical standards as laid down by the Indenting department for the posts of Forester, Wildlife Forester and Wildlife Guards/Antipoaching Guards, Forest Guard:

Physical Standard Test:	Height:
	For Male : minimum 162 Cms For Female : minimum 152 Cms
Physical Efficiency Test:	25 Kms Walk to be completed in 4 hours.


Note: No relaxation in criteria for PST/PET has been communicated by the Indenting Department.

- Passing PST and PET is mandatory and the same will be qualifying in nature. No marks are to be awarded.
- Candidates who do not have minimum height shall not be considered for the PET and shall be treated as disqualified.
- The female candidates who are pregnant, shall not be allowed for the PET and she may be declared temporarily unfit until the confinement is over. The vacancy against which the woman candidate, if in merit for selection, would be kept reserved for her. She would be re-examined for PST/PET six weeks after the date of confinement, subject to production of medical certificate of fitness from Chief Medical Officer. If she is found fit in PST/PET, she may be appointed to the post kept reserved for her.

8. The Candidates are directed to bring the following documents on the scheduled date of PST/PET:

- i. Admit Card, which will be made available to the candidates 5 days prior to the scheduled date of PST/PET (at <https://www.lahdssrb.in/>)
- ii. Physical Fitness Certificate from Chief Medical Officer in the prescribed format at Annexure-III
- iii. Valid Photo ID proof.
