4. The 352 post-wise candidates for the posts of Deputy Forster, Wildlife Guard/Forest Guard were call for Physical Standard Test (PST) and Physical Efficiency Test (PET), vide Notice No. F.No. SECY/LAHD-SSRB/ADVO1/25/PET/11-29 dated 03-01-2026

Vide Notice No.SECY/LAHD-SSRB/ADV01/25/COUNSELL/174-88 dated:17-01-2026, 167 posts-wise candidates were shortlisted for the Counselling Session in person or through Authorized person at the Government Boys Higher Secondary School Leh (**Paras Hall**) on 19-01-2026 to seek preference and allotment of Post and Department on the basis of merit.
